1. Remove the tb Minuteman saturated Refill roll from the bag.
2. Place the Refill roll inside your empty towelette container.
3. Pour excess liquid from the bag onto the roll in the container.
4. Pull up a corner of the first towelette from the centre of the roll and push through the 'X' in the lid.
5. Replace lid tightly on the towelettes container.
6. Replace the calendar on the lid with the blank one supplied with each bag.

Product Description

tb Minuteman is an intermediate level hard surface disinfectant as well as a tuberculocide, virucide and fungicide. **tb Minuteman** is designed for use in dental and medical clinics, hospitals and nursing homes where disinfection and prevention of cross-contamination is of prime importance. **tb Minuteman** is safe for use on non-porous environmental hard surfaces, such as counters, trays, tables, etc. **tb Minuteman** will not stain or leave residual smears after drying. **tb Minuteman** is not for use in hospital nurseries.

tb Minuteman provides complete tuberculocidal activity against:

- Mycobacterium bovis (BCG)

Directions for Use

Pre-clean the surface by wiping with a towelette to remove organic soil. Dispose of towelette. To disinfect the pre-cleaned surface, apply **tb Minuteman** liberally by wiping the surface with a towelette until the surface is thoroughly wet. Ensure the surface remains wet for at least 1 minute at room temperature. Then wipe the surface dry.

Once opened, the unused portion of the product may be stored tightly in the tub container for up to 60 days.

***This product is intended for use against HIV-1 in settings where the virus would be expected to be encountered, such as settings where contamination by blood or body fluid is likely.**

Personal Protection: Personnel that clean items soiled with blood or body fluids must wear appropriate personal protective equipment (i.e., barrier protection), such as disposable gloves, gowns, masks or eye coverings

Cleaning: Target surfaces must be cleaned prior to disinfection, because the presence of heavy soil on a surface may reduce the intended disinfectant efficacy of the product.

Infectious Materials Disposal: Any materials used in the cleaning process that may contain blood or body fluids are to be disposed of immediately in accordance with local regulations for infectious materials disposal.

Precautions:

May cause eye irritation. Avoid contact with eyes and skin. Use in a well ventilated area. Avoid excessive inhalation of vapours. Keep out of reach of children.

First Aid:

If swallowed, give a glass of water. If contact with eyes or skin occurs, flush thoroughly with water. For excessive inhalation, remove person to fresh air. Get medical attention if ingested, if contact with eyes occurs or if an irritation persists.

Storage:

Flammable. Keep away from heat, sparks and open flames. Store in a well ventilated environment at room temperature.

Disposal:

Rinse the empty refill bag. Do not reuse the empty refill bag. Dispose of the bag in accordance with municipal and provincial requirements. For information on spills and for clean up of spills or the disposal of unused, unwanted product, consult the SDS or contact maxill or the provincial regulatory agency.
